From the Supervisory Committee


The Supervisory Committee is charged with ensuring that UFCU maintains accurate reporting and excellent management practices to adequately safeguard our Members' assets. We focus on helping to maintain internal controls, produce accurate financial reporting, and ensure that relevant plans, policies, and procedures are in place.

As part of the committee's ongoing work, we regularly review management practices, risk, regulatory compliance, and operational issues. We also monitor governance matters, direct internal audits, and respond to Member letters of complaint sent to the National Credit Union Administration (NCUA). We strive to make sure all issues are addressed fairly.

Each year, we engage a third party to audit UFCU's financial statements. Based on the 2019 audit

conducted by Moss Adams LLP, we are pleased to report the auditors determined UFCU's financial statements present fairly, in all material respects, the financial position of UFCU in accordance with generally accepted accounting principles. Members may access the audit report upon request.

We appreciate the support and commitment of the UFCU Board and leadership team for their assistance in addressing all audit and NCUA examination issues.

From the Treasurer

Austin's popularity as a place to live, work, and do business continued in 2019. The strong economy, thriving job opportunities, and brisk housing market kept our financial services in high demand. Members turned to UFCU for high quality, competitively priced products and exceptional customer service — and we are proud to have met those needs.

Loan disbursements in 2019 totaled \$2.1 billion, boosting total loans outstanding to \$2.27 billion, an increase of \$143 million, or 7%, from 2018. We helped Members buy 19,000 vehicles and 2,800 homes. Member deposits grew by \$248 million, or 12%, bringing the year-end total to \$2.39 billion. Total assets at year-end were \$2.68 billion, a 12% annual growth rate. Together with more than \$536 million in Member investments under our wealth management program, total assets under management amount to \$3.22 billion. On revenue and gain from sale of investments totaling \$194

million, UFCU generated a net income of \$28 million, representing a return on average assets of 1.08%, elevating Member equity by 13% to \$240 million. At year-end, our net worth ratio was a healthy 9.20%.

We are indebted to the many volunteers who devote their time and expertise to the Asset Liability Management/Budget Committee. The committee reviews our financial performance, establishes and monitors financial policies, and determines financial objectives. Through our continued financial strength, UFCU is well positioned to continue meeting the evolving needs of our 315,000 Members.

In 2019, we invested thousands of employee volunteer hours to support our partners who put students on the track toward higher education. As a social purpose credit union, our goal is to enable everyone in our community to achieve greater levels of prosperity. We also believe UFCU is uniquely suited to positively impact three issues that form the basis of financial health: education, employment, and housing. Success in each of these areas can create a cycle — in which more opportunities lead to more success, to more opportunities, and so on, thus reinforcing a virtuous circle of opportunity.

One of our partners and an innovative nonprofit with a high rate of success is Breakthrough Central Texas. They create a path to college for students who will become the first in their families to earn a degree. Devoted to educational equity, they begin with middle school students from low-income communities and continue supporting them through college graduation, a remarkably long time for this kind of work.

Breakthrough belongs to the Austin College Access Network (ACAN), powered by the E3 Alliance, which increases postsecondary success for underserved students. UFCU supports ACAN with the hope of ensuring success for all Central Texas students. Kate Garrett is the director of corporate partnerships at Breakthrough.

“We’ve been fortunate to have a comprehensive partnership with UFCU. Their funding, donations, and of course their fantastic volunteer participation — We can really feel the impact,” Garrett said.

UFCU will continue supporting organizations like Breakthrough who align to our mission, particularly those who improve education access, which in turn leads to improved employment and housing opportunities. In this way, the virtuous circle continues.

Consulate W is a proud participant of the first cohort of UFCU Scholars at The University of Texas at Austin. The program delivers tools for financial health, career readiness, networking, and more. Each scholar receives tangible benefits:

- A monetary scholarship
- A summer savings program worth up to \$150
- Online financial health education
- A personal financial consultation

"I am lucky enough to be a UFCU Scholar, so I take advantage of the program as much as possible," Consulate shared. "I opened a savings account and learned a lot. UFCU breaks things down very well, and it has really helped me." On track to graduate in 2021, Consulate is majoring in sustainability studies. She's learning how to make the best use of our planet's natural resources, which she believes is crucial to the state of our planet.

"My goal is to help underserved populations find their way to green infrastructure. If I can help others find an ethical way to build, I'd like to do that."

Senior Relationship Management Specialist Christine Hickey helped design the inaugural Scholars program.

"We're eager to extend the program to all of our higher education partners," Hickey said. "We designed this program to allow each partner to customize and meet the unique needs of their students. We want to position students to succeed so they can also give back. We can't wait to see what great things come to our communities as a result."

Driving Financial Health

The UFCU approach to **financial health focuses on empowering individuals** to take control of their future.

Financial health is often misunderstood. It not only applies to those who struggle, financial health is important for people of all walks of life. Monica Muñoz Andry leads UFCU toward measurably improving people's lives through our financial health programs.

"Independent of income, debt, or credit score, financial health means achieving goals while handling life's uncertainties," said Andry. UFCU's step-by-step approach focuses on education, action planning, and resources for putting people in control of their future:

1. **Raise Awareness** — A financial health score and recommendations for action items to save, plan, borrow, and spend wisely lead to a better understanding of where participants fall on the financial health spectrum.

2. **Build Resilience** — Program participants create goals, develop a plan, and connect to resources, including a personal financial advisor. Every plan is individualized and delivers a solid path to progress. The definition of success is no longer an unknown,

which is a real stressor for most people.

3. **Create a Safe Space** — Sharing personal goals, dreams, and struggles is key to success. Financial topics are often taboo, but most people are surprisingly transparent when it comes to sharing their experience to help others.

Put these steps together, and you've got a comprehensive program to meet the unique needs of anyone who wants to take control of their financial future.

In 2020 and beyond, UFCU Members will be able to choose from free seminars, money meet-ups, one-on-one personal financial sessions, an online education center, a mobile app, and more, all targeted at empowering individuals to improve their financial health their way, at their pace.

"We've long held that a community can truly prosper when its Members are financially healthy, and that's what we're going for," Andry said.



Partnering for Prosperity

As a social purpose credit union, we promote greater levels of prosperity through meaningful investments in our community. Goodwill Central Texas helps at-risk individuals find employment. They empower more than 10,000 people annually through education, career training, and employment. A longstanding partner who has been with our credit union for years, Goodwill employees have taken advantage of our financial health program since 2019.

Rachel Hampton seized the opportunity to participate, as a UFCU Member and as director of workforce advancement for Goodwill. She understands that education is key to empowerment.

“We want to bring financial wellness to as many people as we can. We want to impact entire generations, so partnering with UFCU to raise awareness around financial health was easy to say yes to,” she said. Goodwill knows that success requires reliable employment, a stable income at a living wage, and access to many other resources that lead to self-sufficiency.

Finding Financial Freedom

If you ask Hampton, financial health is really all about freedom: to know your bills will be paid and you can still live the life you want to live. The focus on building resilience through savings is essential.

“From the perspective of trying to increase equity for all, financial health is so important, and it is on a spectrum,” she said. “We all need to understand our finances and take control; we need the empowerment to be successful. This is not just for the vulnerable. Even people who are thriving need guidance. We all need support.”

Finances — The Final Frontier

Hampton also reiterated the need for safe spaces to discuss finances. “We have become more open as a society, but finances are still a private matter,” Hampton noted. “It’s the final frontier! The one-on-one sessions offer a fantastic balance of privacy, compassion, and accountability that helps participants be successful!”

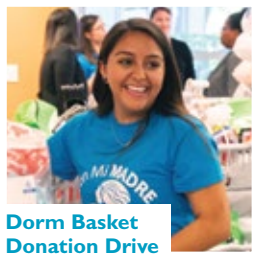

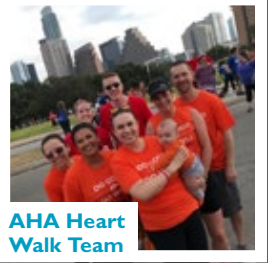

UFCU's DO GOOD program supports mission-driven organizations dedicated to improving financial health.

Our DO GOOD program empowers UFCU employees to give back with 32 annual hours of paid volunteer time off for the sustainable development of our communities. Karen Coker makes good use of this benefit by giving back to Dress for Success Austin® (DfSA).

The DO GOOD program supports many mission-driven organizations dedicated to improving financial health in our communities. Coker was introduced to DfSA by the DO GOOD program and drawn to their mission. They empower women to achieve economic independence via professional attire and career services. With a staff of only four, DfSA hosts more than 300 active volunteers and 1,000 clients annually because 97% of what they do is thanks to volunteers like Coker.

"I come from humble beginnings. My parents and grandparents joined forces so we could move into a more affluent neighborhood. Their collaboration had a powerful influence on me," Coker shared. Her philosophy is always to give, knowing others may not.

"DfSA creates a comfortable experience so women feel

empowered. That can be life changing," Coker said.

Candy Cantrell, who manages volunteers and inventory at DfSA, emphasized the remarkable change that often takes place inside the walls of DfSA.

"We are fortunate to see great transformation here," she said. "Our UFCU volunteers are really helping women in Central Texas. The clothing is just one part of it. Participants get an immediate confidence boost, make connections, and learn how to remove barriers to success," Cantrell explained.

Coker and her fellow DO GOOD volunteers demonstrate how powerful personal philanthropy can be. Coker summed it up nicely: "When I can help make a connection and help make things better, that's when I feel that I've really done something."

Internships Boost Student Success

After years of planning, UFCU and St. Edward's University (SEU) leveraged our long-standing partnership to develop a comprehensive internship program designed to decrease the time between graduation and gainful employment. The first cohort successfully completed their internships during the summer of 2019.

On the surface, an internship program simply connects students with summer jobs. But at its best, an internship can introduce young professionals to organizations that make a difference, to leaders and individual contributors who make positive change, to the qualities and culture that make us who we are as a community.

Jason De La Rosa, interim director of career and professional development at SEU, believes it's all about connections: "Who better to recommend to our students for experiential learning than our own partner? UFCU — who we know to be a reputable presence in our community, who already has a significant connection point to our university. It's very

easy for us to say, this is an excellent organization who cares a lot about the students and our community." Community is, after all, of utmost importance to SEU and UFCU.

De La Rosa believes this is a powerful takeaway for students, and he's excited about pushing ahead. Giving students a comprehensive way to discover their best selves and uncover their ideal career path can't happen without experiential learning and good old-fashioned interactions.

"We're grateful to UFCU for their willingness to partner with us to create such an amazing experience for our students and for Austin. This is really about building relationships and strengthening our community," De La Rosa said.

UFCU plans to host more interns this summer, and opportunities will extend to all of our higher education partners (The University of Texas at Austin, Austin Community College, Concordia University, Huston-Tillotson University, and Texas State University).
